### Instructions

The cost of postage and handling charges incurred by the Nebraska Department of Revenue (Department) to mail cigarette tax stamps by registered insured mail must be included and paid by the cigarette wholesale dealer at the time the purchase order for Nebraska cigarette stamps is submitted.

**Calculation.** To calculate the amount to be remitted, refer to the quantity of stamps purchased to be sent to the postal zones listed and the corresponding dollar amount. The postal zones listed represent the U.S. Postal Service's postal zones for mail sent from the Department's Lincoln office. If your zip code prefix is not listed, please contact the Department for information to determine your postal zone and the related postage and handling fee. If you would like to use your own delivery service, you must provide your account number, street address, city, state, and zip code.

**Combination Order.** For example, if you order a roll of 30,000 stamps and sheets of 1,500 stamps, or any other combination of stamps, you must add together the different amounts owed for each type and quantity of stamps ordered, and place the total amount owed on line 13 of the Purchase Order for Nebraska Cigarette Tax Stamps.
