## General Fund Receipts – July 2017

AUGUST 15, 2017 (LINCOLN, NEB.) — **July Gross Receipts:** Tax Commissioner Tony Fulton reports that gross General Fund receipts for July were \$331 million, which is 2.6% below the certified forecast of \$340 million.
