Education Sessions Set for New Ag Sales Tax Exemption


LINCOLN – As a result of LB 96 and effective October 1, 2014, sales of all repair and replacement parts used to repair agricultural machinery and equipment used in commercial agriculture are exempt from sales and use taxes.
