## General Fund Receipts — July 2016

LINCOLN — **July Gross Receipts:** Tax Commissioner Tony Fulton reports that gross General Fund receipts for July were \$305 million, which is 2.2% below the certified forecast of \$312 million.

Gross Sales and Use: 2.8% above forecast
 Gross Individual Income: 8.4% below forecast
 Gross Corporate Income: 35.7% below forecast
 Gross Miscellaneous: 4.1% above forecast

July Tax Refunds: Tax refunds for July were \$71 million, which is 21.1% above the certified forecast of \$58 million.

July Net Receipts: Net receipts for July were \$235 million, which is 7.6% below the certified forecast of \$254 million.
