Instructions

- Column A.** Print the name of the supplier from whom your company purchased each brand family of RYO tobacco that was reported on your Nebraska Tobacco Products Tax Return, Form 56, and sold to customers in Nebraska.
 - Column B.** Print the brand family name of the RYO tobacco sold in Nebraska.
 - Column C.** Enter the total number of ounces of RYO tobacco products by brand family that your company reported on Form 56 and sold in Nebraska.
- Convert the number of ounces to equivalent cigarettes by dividing ounces by .09.
