Instructions

Who May File This Application. Any sales tax exempt governmental entity or sales tax exempt organization that uses credit or debit cards which are directly billed to the exempt entity or organization to pay for its purchases of property, services, and lodging can file this application. The <u>federal government</u> and its agencies and the <u>state of Nebraska</u> and its agencies cannot use this Application since they have specific cards that they use to document their exempt status.

Purpose of Application. Upon approval of this Application, the Nebraska Department of Revenue will issue an exemption permit that is to be used in conjunction with a <u>Nebraska Resale or Exempt Sale Certificate</u>, Form 13, and the credit or debit card identified on this application to purchase property, services, and lodging exempt from sales, use, and lodging taxes. This exemption permit will confirm that any purchases made using the identified credit or debit card will be directly billed and paid for by the sales tax exempt governmental entity or sales tax exempt organization.

Important: If more than one credit or debit card has been issued to the sales tax exempt governmental entity or sales tax exempt organization, a separate application is required for each card issued. The name on the card must match the name on this application.
