General Fund Receipts — June 2022

JULY 15, 2022 (LINCOLN, NEB.) — **June Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for June were \$769 million, which is 14.7% above the forecast of \$670 million.

June Tax Refunds: Tax refunds for June were \$156 million, which is 37.6% above the forecast of \$113 million.

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2021-22 were \$6.349 billion, which is 10.9% above the forecast of \$5.725 billion.

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board (NEFAB) on February 28, 2022. This forecast was divided into consensus monthly estimates by the Tax Commissioner and Legislative Fiscal Analyst on March 3, 2022.

Also, as required under Neb. Rev. Stat. § 77-4602(2), actual net General Fund net receipts for fiscal year 2021-22 were \$6,348,994,703 compared to the certified forecast¹ of \$4,879,609,919 (detail in table 4).
