General Fund Receipts — November 2022

DECEMBER 15, 2022 (LINCOLN, NEB.) — **November Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for November were \$693 million, which is 0.3% above the forecast of \$691 million.

Gross Sales and Use: 0.7% below forecast
 Gross Individual Income: 2.6% above forecast
 Gross Corporate Income: 34.5% below forecast
 Gross Miscellaneous: 6.3% above forecast

November Tax Refunds: Tax refunds for November were \$173 million, which is 53.0% above the forecast of \$113 million.

November Net Receipts: Net receipts for November were \$520 million, which is 10.0% below the forecast of \$578 million.
