### General Fund Receipts — July 2022

AUGUST 15, 2022 (LINCOLN, NEB.) — **July Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for July were \$421 million, which is 0.4% below the forecast of \$423 million.

**July Tax Refunds**: Tax refunds for July were \$101 million, which is 4.7% below the forecast of \$106 million.
