Instructions

Who May Order. Nebraska stamping agents who affix cigarette tax stamps to packages of cigarettes must complete this order form.

Where to Order. The completed order form with proper remittance (line 10) must be filed before any cigarette tax stamps will be issued. Cigarette tax stamps can only be ordered from the Lincoln office of the Nebraska Department of Revenue (DOR).

Order Quantity. Cigarette tax stamps for packages of 20 or fewer cigarettes are sold in rolls of 30,000 or sheets of 150 with a minimum order of 1,500 stamps. The balance due (line 10) must be submitted with each purchase order.

Postage and Handling. The cost of postage and handling charges incurred by the DOR to mail cigarette tax stamps by registered, insured mail must be included and paid by the stamping agent at the time the order is submitted. Refer to the current [Nebraska Cigarette Tax Stamp Postage and Handling Schedule](#) for the proper amount of postage and handling charges to be entered on line 7a. The schedule can be found on our website at revenue.nebraska.gov, by clicking “Businesses” and then on “Cigarettes & Other Tobacco Products”, then scrolling down to the “Nebraska Cigarette Tax Stamp Postage and Handling Schedule.” Select “yes” in 7b to pick up the cigarette tax stamps at the Nebraska Department of Revenue’s office located at 301 Centennial Mall South Lincoln, NE 68509-4818.

If you are using a delivery service, provide the name of the delivery service and account number. The DOR will insure with the delivery service at the stamping agent’s cost, the actual purchase price of the cigarette tax stamps up to the delivery service’s maximum amount allowable declared value unless “yes” is selected in 7d.

The stamping agent is responsible for any cigarette tax stamps lost during transit and purchasing any replacement cigarette tax stamps.

Credit. Credit is allowed for packs of cigarettes returned to the manufacturer as unsaleable that have a Nebraska cigarette tax stamp on them. A credit memorandum for returned cigarettes is issued by the DOR and must be attached to the order on which a credit is claimed. Do not attach the manufacturer’s affidavit or claim credit before the credit memorandum has been issued.

Credit for cigarette tax will be allowed for packs of cigarettes sold to Native American Indian Tribal Members in the Tribe’s Indian country tax-free when supported by a [Nebraska Credit Computation for Cigarettes and Tobacco Products Sold to Native American Reservation Indians, Form 68](#).

Authorized Signature. This order form must be signed by the owner, partner, corporate officer, or other individual authorized to sign by a [Power of Attorney, Form 33](#) on file with the DOR.
