## Instructions

**Who Must File.** Any person or business who wants to become: (1) a licensed distributor\* of bingo equipment or pickle card units in Nebraska; (2) a licensed manufacturer of bingo equipment or pickle card units in Nebraska; or (3) a licensed manufacturer-distributor of county/city lottery supplies and/or equipment in Nebraska, must file a Nebraska Application for Manufacturers, Distributors, and Manufacturer-Distributors, Form 50A.

\*To be eligible for a distributor's license, the applicant must have its principal office located in Nebraska.

**What Must be Filed.** Any person or business seeking a license as a manufacturer, distributor, or manufacturer-distributor must complete and submit a Form 50A to the Department.

**Fingerprints and Background Check Waiver Form.** Neb. Rev. Stat. 9-1,104 requires certain applicants to be fingerprinted for criminal background investigation purposes. Please refer to the Instructions for Completing Fingerprint Application to determine who is subject to this requirement and whether any exceptions may apply. Each individual required to be fingerprinted must also submit to the Department, a Background Check Waiver Form and the proper fees.

**Additional Attachments Required.** If the applicant is a partnership, provide a copy of the partnership agreement. If the applicant is a corporation, provide a copy of the articles of incorporation and all amendments. If the applicant is a LLC, provide a copy of the articles of organization.

**Personal History Record and Background Disclosure Form (Disclosure Form).** Each person required to be fingerprinted must also complete and submit a Disclosure Form. The filing of a Disclosure Form can be waived for a spouse if the spouse files an Affidavit by Spouse for Waiver of Fingerprinting and/or Personal History Record and Background Disclosure Form indicating they will have no interest, directly or indirectly, in the operation or profit of the business.

For purposes of the Disclosure Form and fingerprinting requirements, a "person or entity" is a debt holder of a corporation or partnership if the person or entity holds any mortgages, notes, bonds, convertible debentures, or other obligations, whether written or oral, issued by the corporation or partnership. For purposes of this form, a "debt holder" does not include any financial institution organized or chartered under the laws of Nebraska, any other state, or the United States relating to banks, savings institutions, trust companies, savings and loan associations, credit unions, installment loan licensees, or similar associations organized under the laws of Nebraska and subject to supervision by the Department of Banking and Finance. A person or entity is an "equity holder of the corporation or partnership" if the person or entity holds any capital stock, whether common or preferred, issued by the corporation or partnership.

**When and Where to File.** Licenses issued to manufacturers and distributors of bingo equipment, pickle card units, and licenses issued to manufacturer-distributors of county/city lottery supplies and/or equipment expire on September 30 of every odd-numbered year and may be renewed biennially. License renewal applications must be submitted to the Department at least 45 days prior to the expiration date of the license.

Licenses are not transferable, and license fees are not refundable.

Prior to any person or business engaging in business in Nebraska as a licensed manufacturer, distributor, or manufacturer-distributor, each person or business must have physical possession of the license issued by the Nebraska Department of Revenue (Department).

## Terms

**Bingo Equipment.** Bingo equipment is all equipment which is actually used, made, or sold for use in bingo games regulated by the Nebraska Bingo Act. Bingo equipment includes, but is not limited to:

- Bingo balls;
- Bingo card monitoring devices;
- Disposable paper bingo cards;
- Flash boards;
- Instant bingo boards;
- Machines or other devices used for number and letter selection;
- Other devices commonly used in the direct operation of bingo; and
- Reusable shutter cards or hard cards.

Bingo equipment does not include:

- Bingo chips;
- Chairs;
- Daubers;
- Items which are used directly by the individual player;
- Other property not directly used in the operation of the game; or
- Tables.

Bingo game sets commonly manufactured and sold as children's games are presumed not to be bingo equipment for the purpose of this definition unless the set, or a portion of the set is actually used in bingo games required to be licensed in Nebraska.

**Bingo Supplies.** Bingo supplies are any items other than bingo equipment which may be used by an individual player to assist in the playing of bingo. Bingo supplies include, but are not limited to:

- Chips;
- Daubers; and
- Items used to mark the numbers called on the player's bingo card.

**County/City Lottery Equipment.** County/city lottery equipment is all proprietary devices, machines, and parts used in the manufacture or maintenance of equipment which is used in and is an integral part of the conduct of any lottery activity authorized or regulated under the Nebraska County and City Lottery Act. County/city equipment includes, but is not limited to:

- Computerized keno systems;
- Electronic blower machines;
- Keno balls;
- Other electronic selection devices;
- Rabbit ears; and
- Random number generators.

**County/City Lottery Supplies.** County/city lottery supplies are all boards, cards, sheets, tickets, or other supplies which are used in and which are an integral part of the conduct of any lottery activity authorized and regulated under the Nebraska County and City Lottery Act. County/city lottery supplies include, but are not limited to, lottery tickets.

County/city lottery supplies do not include:

- Crayons;
- Keno paper;
- Markers; and
- Other supplies which do not have a direct effect on the outcome of the lottery activity.

**Distributor.** A distributor is any person or business who purchases or otherwise obtains: (1) bingo equipment from a licensed manufacturer to sell, lease, distribute, or otherwise provide in this state to a licensed organization or licensed commercial lessor for use in a bingo occasion regulated by the Nebraska Bingo Act; or (2) pickle card units from a licensed manufacturer to sell, distribute, or otherwise provide in this state to licensed organizations. "Distributor" does not include a person or business who exclusively provides bingo supplies and/or equipment for use in bingo games which are not subject to regulation under the Act, nor does it include a person or business who sells only daubers and/or bingo card markers.

**Manufacturer.** A manufacturer is any person or business who assembles, produces, makes, or prints any bingo equipment, or who assembles from raw materials or subparts a completed piece or pieces of pickle cards or pickle card units. "Manufacturer" does not include a person or business who manufactures only bingo supply items (for example, daubers, chips, or glue sticks), or a licensed distributor who places, finishes, or configures disposable bingo paper which has been produced by a licensed manufacturer, into a loose-leaf or book form, or some other format for distribution to licensed organizations.

**Manufacturer-Distributor.** A manufacturer-distributor is any person or business who assembles, produces, makes, prints, or supplies county/city lottery equipment and/or supplies for sale, use, or distribution in Nebraska. Any person or business who only prints tickets for use in a keno lottery or traditional ticket lottery is not required to be licensed as a manufacturer-distributor.

**Pickle Card.** A pickle card is any disposable card, board, or ticket which accords a person an opportunity to win a cash prize by opening, pulling, detaching, or otherwise removing one or more tabs from the card, board, or ticket to reveal a set of numbers, letters, symbols, configurations, or any combination. A pickle card includes, but is not limited to, any card known as a:

- Break-open;
- Numeral;
- Pickle;
- Pickle ticket;
- Pull-card;
- Pull-tab;
- Pull-tab board; or
- Punchboard.
