## General Fund Receipts – February 2019

MARCH 15, 2019 (LINCOLN, NEB.) — **February Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for February were \$498 million, which is equal to the certified forecast of \$498 million.

Gross Sales and Use: equals forecast<sup>1</sup>
 Gross Individual Income: equals forecast
 Gross Corporate Income: equals forecast
 Gross Miscellaneous: equals forecast

**February Tax Refunds**: Tax refunds for February were \$201 million, which is equal to the certified forecast of \$201 million.

**February Net Receipts**: Net receipts for February were \$296 million, which is equal to the certified forecast of \$296 million.

Net Sales and Use: equals forecast
 Net Individual Income: equals forecast
 Net Corporate Income: equals forecast
 Net Miscellaneous: equals forecast

**Fiscal Year Net Receipts**: Net General Fund receipts for fiscal year 2018-19 were \$2.924 billion, which is equal to the certified forecast of \$2.924 billion.

Net Sales and Use: equals forecast
 Net Individual Income: equals forecast
 Net Corporate Income: equals forecast
 Net Miscellaneous: equals forecast

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board on February 28, 2019. This forecast was divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on March 13, 2019. At the February 28, 2019 meeting, the Board revised the forecast for the current fiscal year downward by \$80 million to \$4.720 billion, in comparison to the October 26, 2018 forecast.
