## Charitable Gaming Activity April – June 2016

LINCOLN – The Nebraska Department of Revenue, Lottery and Charitable Gaming Division reported today that total dollars wagered on charitable gaming activities for April through June 2016 were \$71.0 million, which is 6.21% less than the previous quarter, when \$75.7 million was wagered.
