General Fund Receipts — April 2019

MAY 15, 2019 (LINCOLN, NEB.) — **April Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for April were \$805 million, which is 10.9% above the certified forecast of \$726 million.

April Tax Refunds: Tax refunds for April were \$146 million, which is 4.7% below the certified forecast of \$153 million.

April Net Receipts: Net receipts for April were \$660 million, which is 15.1% above the certified forecast of \$573 million.

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2018-19 were \$3.927 billion, which is 2.6% above the certified forecast of \$3.829 billion.

Net Sales and Use: 0.4% above forecast
Net Individual Income: 1.2% above forecast
Net Corporate Income: 23.8% above forecast
Net Miscellaneous: 3.0% above forecast

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board on February 28, 2019. This forecast was divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on March 13, 2019. At the April 25, 2019 meeting, the Board revised the forecast for the current fiscal year upward by \$45 million to \$4.765 billion, compared to the certified forecast. By law, only downward revisions to the forecast are recertified, so the comparisons made in this release are still based on the forecast certified on March 13, 2019.
