SEPTEMBER 13, 2019 (LINCOLN, NEB.) – **August Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for August were \$527 million, which is 2.7% above the certified forecast of \$513 million.

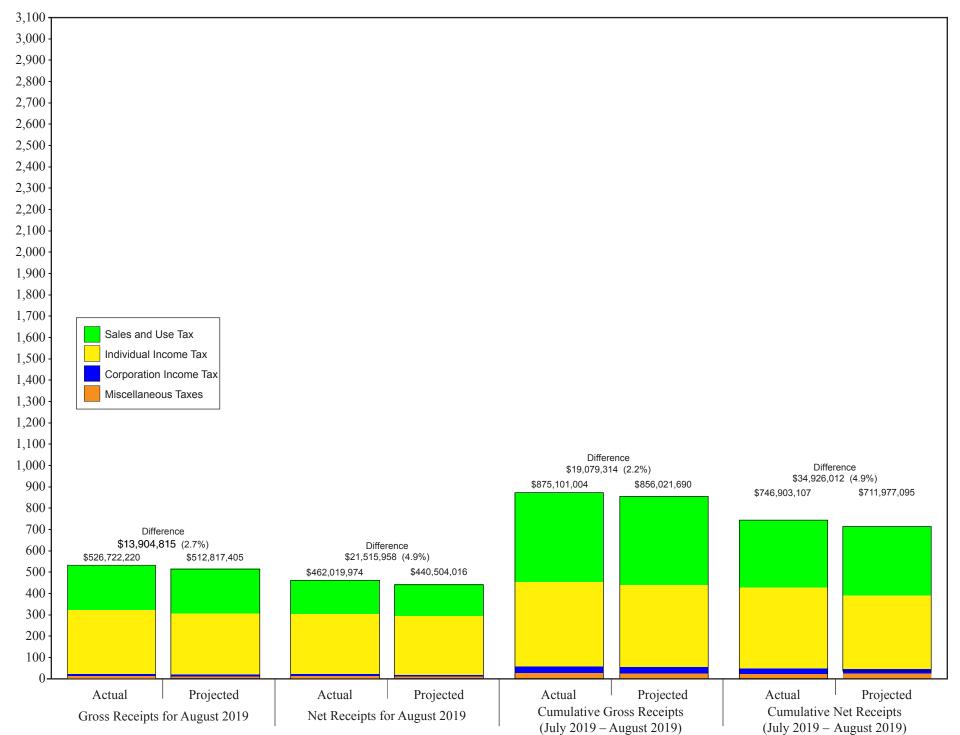
