General Fund Receipts – July 2019

AUGUST 15, 2019 (LINCOLN, NEB.) — **July Gross Receipts:** Tax Commissioner Tony Fulton reports that gross General Fund receipts for July were \$348 million, which is 1.5% above the certified forecast of \$343 million.

July Tax Refunds: Tax refunds for July were \$63 million, which is 11.5% below the certified forecast of \$72 million.

July Net Receipts: Net receipts for July were \$285 million, which is 4.9% above the certified forecast of \$271 million.

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board on April 25, 2019. This forecast was adjusted for legislation passed in 2019, divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on July 12, 2019.
