General Fund Receipts – June 2019

JULY 15, 2019 (LINCOLN, NEB.) – **June Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for June were \$620 million, which is 6.6% above the certified forecast of \$581 million.

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2018-19 were \$4.896 billion, which is 3.7% above the certified forecast of \$4.720 billion.

- The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board on February 28, 2019. This forecast was divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on March 13, 2019. At the April 25, 2019 meeting, the Board revised the forecast for the current fiscal year upward by \$45 million to \$4.765 billion, compared to the certified forecast. By law, only downward revisions to the forecast are recertified, so the comparisons made in this release are still based on the forecast certified on March 13, 2019.


