## **General Fund Receipts – August 2020**

SEPTEMBER 15, 2020 (LINCOLN, NEB.) — **August Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for August were \$588 million, which is 11.9% above the certified forecast of \$525 million.

**August Tax Refunds**: Tax refunds for August were \$74 million, which is 6.6% below the certified forecast of \$80 million.

**August Net Receipts**: Net receipts for August were \$513 million, which is 15.2% above the certified forecast of \$446 million.
