General Fund Receipts – June 2020

JULY 15, 2020 (LINCOLN, NEB.) — **June Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for June were \$578 million, which is 0.4% above the certified forecast of \$576 million.

June Tax Refunds: Tax refunds for June were \$69 million, which is 17.0% below the certified forecast of \$83 million.

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board (Board) on April 25, 2019. This forecast was adjusted for legislation passed in 2019, divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on July 8, 2019. At the February 28, 2020 meeting, the Board revised the forecast for the current fiscal year upward by \$115 million to \$5.205, in comparison to the October 24, 2019 meeting, which was set at \$5.090 billion. By law, only downward revisions to the forecast are certified, so the comparisons made in this release are still based on the forecast certified on July 8, 2019.
