General Fund Receipts – July 2021

AUGUST 13, 2021 (LINCOLN, NEB.) - July Gross Receipts: Tax Commissioner Tony Fulton reports that gross General Fund receipts for July were \$399 million, which is 2.1% above the forecast of \$390 million.

July Tax Refunds: Tax refunds for July were \$87 million, which is 1.6% below the forecast of \$89 million.

This forecast was adjusted for legislation passed in 2021, divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on July 14, 2021.
