General Fund Receipts – March 2021

APRIL 15, 2021 (LINCOLN, NEB.) – **March Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for March were \$566 million, which is 12.1% above the certified forecast of \$505 million.

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2020-21 were \$4.133 billion, which is 15.6% above the certified forecast of \$3.574 billion.

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board on July 23, 2020. This forecast was adjusted for legislation passed in 2020, divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on August 14, 2020. At the February 26, 2021 meeting, the Board revised the forecast for the current fiscal year upward by \$204 million to \$5.490 billion, in comparison to the October 26, 2020 meeting, which was set at \$5.286 billion. By law, only downward revisions to the forecast are certified, so the comparisons made in this release are still based on the forecast certified on August 14, 2020.


