General Fund Receipts – November 2021

DECEMBER 15, 2021 (LINCOLN, NEB.) — **November Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for November were \$650 million, which is 5.0% above the forecast of \$619 million.

November Tax Refunds: Tax refunds for November were \$105 million, which is 7.5% below the forecast of \$113 million.
