# General Fund Receipts – January 2022

FEBRUARY 14, 2022 (LINCOLN, NEB.) – **January Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for January were \$658 million, which is 25.0% above the forecast of \$526 million.
