### General Fund Receipts – March 2022

APRIL 15, 2022 (LINCOLN, NEB.) — **March Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for March were \$669 million, which is 7.4% above the forecast of \$623 million.

March Tax Refunds: Tax refunds for March were \$250 million, which is 27.4% below the forecast of \$344 million.
