General Fund Receipts — April 2024

MAY 15, 2024 (LINCOLN, NEB.) – **April Gross Receipts**: Tax Commissioner James R. Kamm reports that gross General Fund receipts for April were \$970 million, which is 3.7% below the forecast of \$1.007 billion.

April Tax Refunds: Tax refunds for April were \$605 million, which is 28.4% above the forecast of \$471 million.

April Net Receipts: Net receipts for April were \$365 million, which is 32.0% below the forecast of \$536 million.

 Net Corporate Income: 30.9% above forecast

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2023-24 through April were \$6.055 billion, which is 2.4% above the forecast of \$5.916 billion.

 Net Sales and Use: 	0.7% below forecast
 Net Individual Income: 	6.1% below forecast
 Net Corporate Income: 	20.1% above forecast
Net Miscellaneous:	13.9% above forecast

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board (Board) on February 29, 2024. The Board forecast was divided into monthly estimates by the Tax Commissioner and Legislative Fiscal Analyst on March 11, 2024.
