¹Dakota County rate of 0.5% is only added to the state rate for sales made in Dakota County when the location is outside of a municipality that imposes a local sales and use tax rate.

²Gage County rate of 0.5% is imposed on all taxable transactions in Gage County. It is added to the state and any local sales and use tax imposed by a city or village in Gage County.

*This Gage County municipality rate reflects the state, local, and county tax. All other areas in Gage County are only subject to the state rate of 5.5% and the county rate of 0.5%, for a total rate of 6%.
