General Fund Receipts — May 2018

JUNE 15, 2018 (LINCOLN, NEB.) — May Gross Receipts: Tax Commissioner Tony Fulton reports that gross General Fund receipts for May were \$487 million, which is 1.2% below the certified forecast of \$493 million.

Gross Sales and Use: 2.0% below forecast
Gross Individual Income: 1.3% below forecast
Gross Corporate Income: 3.3% above forecast
Gross Miscellaneous: 4.7% above forecast

May Tax Refunds: Tax refunds for May were \$95 million, which is 13.3% above the certified forecast of \$84 million.

May Net Receipts: Net receipts for May were \$392 million, which is 4.2% below the certified forecast of \$409 million.

Net Sales and Use: 2.8% below forecast
Net Individual Income: 6.1% below forecast
Net Corporate Income: 10.5% above forecast
Net Miscellaneous: 4.8% above forecast

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2017-18 were \$4.093 billion, which is 1.1% above the certified forecast of \$4.050 billion.

Net Sales and Use: 0.7% below forecast
Net Individual Income: 2.0% above forecast
Net Corporate Income: 1.5% above forecast
Net Miscellaneous: 3.6% above forecast

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board (NEFAB) on October 27, 2017. At this meeting, the NEFAB reduced the FY 2017-18 forecast by \$100 million. This forecast was divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on November 13, 2017. At the February 28, 2018 meeting, the Board revised the forecast for the current fiscal year upward by \$25 million to \$4.530 billion. By law, only downward revisions to the forecast are recertified, so the comparisons made in this release are still based on the forecast certified on November 13, 2017.
