General Fund Receipts — April 2020

MAY 15, 2020 (LINCOLN, NEB.) — **April Gross Receipts**: Tax Commissioner Tony Fulton reports that gross General Fund receipts for April were \$469 million, which is 41.0% below the certified forecast of \$795 million.

April Tax Refunds: Tax refunds for April were \$124 million, which is 21.4% below the certified forecast of \$158 million.

April Net Receipts: Net receipts for April were \$345 million, which is 45.9% below the certified forecast of \$637 million.

Fiscal Year Net Receipts: Net General Fund receipts for fiscal year 2019-20 were \$4.001 billion, which is 0.1% above the certified forecast of \$3.997 billion.

The comparisons in this report are based on the forecast made by the Nebraska Economic Forecasting Advisory Board (Board) on April 25, 2019. This forecast was adjusted for legislation passed in 2019, divided into monthly estimates and certified to the Clerk of the Legislature by the Tax Commissioner and Legislative Fiscal Analyst on July 8, 2019. At the February 28, 2020 meeting, the Board revised the forecast for the current fiscal year upward by \$115 million to \$5.205, in comparison to the October 24, 2019 meeting, which was set at \$5.090 billion. By law, only downward revisions to the forecast are certified, so the comparisons made in this release are still based on the forecast certified on July 8, 2019.

* On March 23, 2020, Governor Ricketts announced that The Nebraska Department of Revenue would follow the lead of the Internal Revenue Service and postpone the filing deadlines and payment due dates for taxes and tax returns due on April 15 until July 15. This greatly affected April individual and corporate income tax receipts.
